

**Spokane, WA Fall Indoor Competition**

**Guidelines:**

1. Competition Starts at 10am for all dancers. Registration 9:30am to pick up numbers.
2. No entries post marked **prior to August 9th**. Entries to be post marked by September 25<sup>th</sup> to avoid late fee.. Late fee of \$10 if post marked after Sept 25<sup>th</sup>. If entry is late – please email Marie to let her know it is coming.
3. Rules & Regulations of the S.O.B.H.D. will govern all dancing.
4. Dance committee will determine breakdown of classes when all entries have been received.
5. Any dancer not ready when called shall forfeit entry in that event.
6. Dancers will compete in reverse order of entry for all events. (First to enter...last to dance)
7. FUSTA or ScotDance card must be shown upon request. Age for entry is as of Oct 9<sup>th</sup>, 2010.
8. Highland Dances will be danced first. Starting with Beginner Flings.
10. Any protests must accompany a \$25.00 fee and be submitted by the end of the competition.

**Entry Fees: Primary dancers - \$4 a dance. Beginner, Novice, Intermediate & Premier dancers - \$5.50 a dance or \$20.00 for 4 dances/set. U.S. funds only.**
